ARTIST'S INFORMATION PACKAGE

Dear Artist,

You are invited to participate in the 2017 Interlake Juried Art Show. This is an opportunity for Interlake Artists to enter their work into competition, and to have their work adjudicated by Professional Artists from across Manitoba. There are two main entry levels - Adult and Youth - and the art is then separated into 10 different Categories. Participants will receive written critiques from the Jurors.

The Show will be open to the public on Saturday April 29th from noon – 5 pm and Sunday April 30th, from 10:00 - 2.00 pm. Closing ceremony and awards presentation is on Sunday April 30th between 2 - 3 pm. Join us as we celebrate the work of our Interlake Artists at the 2017 Interlake Juried Art Show!

It is the responsibility of the artist to ensure the work is entered in the correct category. Uncategorized works will not be adjudicated. Jurors reserve the right to reassign artwork from one category to another; the jurors' decision is final. See more info under Rules and Criteria.

Entries:

- Adult - \$12.00 per entry
- Youth ages 13-17 - \$5.00 per entry
- Maximum of 6 entries per artist; limit of three in any one category.
- Youth wishing to be judged in the Adult category must pay the Adult fee of \$12.00 per entry.

Deadline for submission April 9th, 2015.

Rules and Criteria: - Work not meeting these conditions will not be accepted.

- Art must be finished, dry and ready to hang, with a wire affixed to the back to ensure that the artwork will hang on the display properly. We will be using Pegboard and Grid panels.
- Artwork must be no more than 3 years old. Previous winning entries of any juried show are not eligible.
- Artwork must be original and not copied from other artists (copyright rules apply).
- Open to artists whose permanent address is located within the Interlake Region of Manitoba.
- All Artwork must be original, **commercial kits and patterns are not eligible**.
- Instructions for hanging, if required must be provided. Should a special display be required, artist must supply it.
- Jurors reserve the right to reassign artwork from one category to another; the Juror's decision is final in all cases.
- Disqualification will result if the work submitted is not that indicated on the entry form.

Sales:

Artists must clearly state whether or not artwork is for sale by marking the sale price on the entry form and on the information tag. Artists are responsible for their own sales. There will be no commission charged by the Gimli Art Club for any pieces sold at the Interlake Juried Art Show. If you are not present your contact information will be shared with the prospective buyer.

Insurance:

No individual or organization assumes responsibility for any loss, damage or injury to any entries and exhibits. The artist is responsible for insuring their work while in transit, while work is stored and on display. Artists should check with their home insurance agents to see if extra insurance is required.

Packaging:

- The artist is responsible for packing works properly in a sturdy container, which will be reused for the return of the artwork. Do not pack with Styrofoam peanuts. *Place name, address, phone number, e-mail address, and the names and number of entries enclosed on the outside of the container.*
- Attach an Information Tag on the back of each piece of artwork. Information tags are provided as a separate attachment.
- **Due to limited space packing material from hand delivered works will not be stored during the show - the exception will be from the works picked up from the secondary depots.**
- Artwork dropped off at secondary depots must be able to be transportable by a van and received at the secondary depots no later than **Noon Thursday April 20th, 2015**

Shipping:

- Shipping is not provided by the Interlake Juried Art Show. Please drop off your artwork at the show location Riverton Recreation Facilities, 175 Reggie Leach Drive, Riverton, Manitoba on Monday April 24th, 9:30 am - 3:30 pm and Tuesday April 25th, 9:00am to 1:00pm. No later.
- Secondary depots will be accepting art for transportation to the show site. Arrangements must be made by artist for pick up immediately following the show from Riverton Recreation Facilities, 175 Reggie Leach Drive, Riverton, Manitoba on Sunday April 30th between 3 pm and 4 pm.

Secondary Depots:

Are located in Ashern, Selkirk, Eriksdale, and Warren.
